

- 1.0 I, the undersigned, on behalf of MYSELF and ALL THOSE for whom I have listed below (“MY PARTICIPANTS”) to gain admission to and use of the events and activities of the EVENT ORGANIZERS voluntarily assume all risks and danger incidental to any event or activity for which admission issued and waive all claims against: AMERICAN EVENT GROUP, INC (AEG), the event sponsor(s), the equipment, property or facility lessees or owner(s), the ticket producer or issuer(s), and the event or activity workers, leaders and assistants (altogether “EVENT ORGANIZERS”) and all others connected with the availability or performance of any event or activity involved. Further, I/WE AGREE that in case of injury, damage or other liability, MY/OUR personal insurance, plans, discounts shall be used first and that after such I/WE AGREE to pay the first \$2500 before any claim is made against EVENT ORGANIZERS or their insurance.
- 2.0 I/WE UNDERSTAND and AGREE:
 - 2.1 Admission is by invitation only and is not transferable to another;
 - 2.2 All volunteer event and activity leaders are afforded liability protections under the U.S. Volunteer Protection Act of 1997 and that reimbursement of expenses are not wages;
 - 2.3 To cover all damages and costs of injuries to self, others or equipment to or directly or indirectly caused by MY PARTICIPANTS;
 - 2.4 EVENT ORGANIZER’s insurance shall be subordinate to MY/OUR insurance(s) or medial service plan(s) and fee reductions or waivers;
 - 2.5 To report to the EVENT ORGANIZERS within 60 minutes of occurrence any and all injuries and sign a written incident report provided by the EVENT ORGANIZERS involved in said injury before leaving site (except in life threatening situations) AND to fully complete all Accident Claim Forms found at <http://claims.amerevent.com> within 60-days of occurrence, and;
 - 2.6 Should I/WE fail to complete these reports, I/WE forfeit any future consideration or claim.
- 3.0 ACKNOWLEDGEMENT OF RISKS AND CAPABILITIES
 - 3.1 ACKNOWLEDGEMENT OF RISKS. I/WE UNDERSTAND and acknowledge there may be a significant amount of both known and unknown risks in the use of EVENT ORGANIZERS equipment and the activities they conduct. I/WE CERTIFY WE and MY PARTICIPANTS have disclosed and any all pre-existing and previous conditions, including but not limited to: head, neck, back, shoulder, arm, leg and torso injuries or pregnancy and will not participate if such may negatively impact or add any risk to them, and that all are fully capable of participating and ALL VOLUNTARILY WISH and AGREE to do so. I/WE ACKNOWLEDGE that exposure to these inherent risks, rigors and dangers may result in, but is not limited to, physical injury from falling, slipping or colliding, emotional trauma, distress, separation, bruising, permanent disability including in extreme cases death to any participant.
 - 3.2 PROPER PREPARIDNESS. I/WE AGREE it is OUR responsibility to learn and fully understand the techniques, methods and procedures for conducting the activities and operating the equipment I/WE use. I/WE agree any participant under 18-years of age shall wear a helmet as well as any participant who wishes to risk head injury or they agree not to participate. I/WE AGREE not to participate if WE are not fully competent in the skills or safety techniques required or the procedures for inspecting, testing and insuring reliability of the equipment used. I/WE ASSUME full responsibility for OUR actions and for their consequences, including without limitation any injury to any person or property or any inconvenience resulting there from or from any other circumstance related to such actions. I/WE AGREE that should we choose not participate or be unable to participate, fees paid are not refundable.
 - 3.3 ASSUMPTION OF RESPONSIBILITIES. I/WE ASSUME full responsibility for OUR actions during OUR participation any EVENT ORGANIZERS program and their consequences, and including without limitation, any damage or injury to ME or MY PARTICIPANTS, other persons or property or any inconvenience resulting there from or from any other circumstance related to such actions, including but not limited to all damages and to event site or location and all objects thereupon.
 - 3.4 NO INTOXICATING SUBSTANCES. I/WE AGREE that no intoxicating substance of any kind will be consumed by ME/US within one hour of the use of any event or activity, especially rides, bounce houses or any activity requiring physical participation and further agree not to participate should I/WE be in any medical distress or potentially still under the influence of any intoxicant. I/WE AGREE no EVENT ORGANIZER is responsible monitoring MY/OUR physical condition or for any resulting claim when this requirement is not followed.
- 4.0 EMERGENCY ACTIONS. In the event of emergency as determined by EVENT ORGANIZERS, if MY/OUR emergency contact cannot be reached I/WE GIVE permission to the physician selected by EVENT ORGANIZERS to hospitalize, secure proper treatment, order injection, anesthesia, or surgery on MY/OUR behalf. I/WE GIVE permission for EVENT ORGANIZERS to administer First Aid and any medication needed for illness or injury. I/WE AGREE that electronic copies or photocopies of this AGREEMENT are to be considered legally valid and binding for any use in obtaining such medical assistance. I/WE AGREE and maintain medical and liability insurance covering US with an appropriate wavier of subrogation rights to reflect the fact that MY/OUR insurance shall
